If you chose to use the **SINGLE PAYMENT SYSTEM**, you need to have completed the process **before September 15<sup>th</sup>**. What you need to do is look over the **Cross Country** schedule and its entry fees and determine an estimate of what your school's participation level would be and then determine your entry fee costs. Listed below are the names/dates of the meets along with the entry fee information. If you choose the **Single Payment** option, you would then send MSTCA a check with this form completely filled out for the meets your school will attend.

If at the end of the season, you owe MSTCA more money, we will then bill you for the difference at which time you need to send us a check for that amount. **However, if the opposite happens, and you do not use the full amount, we will credit your school toward the winter meets.** This will make the processing of billing and receiving checks much easier for both of us.
